- The Financial Markets Authority (FMA) or the Office of the Privacy Commissioner, if required
- Trusted third parties involved in the provision of financial services, with your permission

We will never sell your information to third parties.

5. How We Store and Protect Your Information

We store your personal information securely using both physical and digital protections, including:

- Password-protected systems and encrypted software
- Locked filing cabinets for paper records
- Secure cloud-based platforms (located in compliance with New Zealand privacy laws)

We retain your personal information only as long as necessary to fulfil our obligations to you and our

legal requirements.
